WHEREAS, the National Irrigation Administration – Quezon Irrigation Management Office advertised the Invitation to Bid PROJECT IDENTIFICATION NO. 4AQ-CCN-23-034 INCLUDES THE CONSTRUCTION OF PROTECTION WORKS AT LAGNAS DAM STA. 0+017.00-STA. 0+113.28 U/S RIGHT SIDE AND STA. 0+005.00-STA. 0+113.28 U/S LEFT SIDE OF LAGNAS RIVER IRRIGATION SYSTEM LOCATED AT TIAONG at the PhilGEPS website under Reference No. 10246678 starting October 23, 2023, and posted same at the bulletin boards of IMO Office Bulletin Board;

WHEREAS, among the contents of the Invitation to Bid was the announcement that Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised IRR of R.A. 9184;

WHEREAS, in response to the said advertisement, only three (3) contractors: G.R. BERNALES CONSTRUCTION AND SUPPLIES, M.C. REFAZO BUILDERS and C. VILLASEÑOR JR. CONSTRUCTION signified interest to participate in the bidding and submitted Letter of Intent (LOI) and purchased the non-refundable amount of bid documents;

WHEREAS, a pre-bidding conference was scheduled on October 31, 2023 at the NIA Quezon IMO Conference Room, Lucena City, Quezon to present the technical and financial components of the bid, including the explanation of the different documents to be submitted by each bidder and to discuss the requirements in the Instruction to Bidders, answer bidder queries about the requirements, specifications and other condition of the contract;

WHEREAS, the Opening of Bids was held on November 13, 2023, 1:31 PM with invited observers/representatives from the Commission on Audit (COA), Philippine Institute of Civil Engineer (PICE), Federation of Irrigators Association (IA) and NIA Employees Association of the Philippines- Quezon Irrigation Management Office Chapter (NIAEASP- QIMO Chapter);

WHEREAS, the BAC Technical Working Group (TWG) made detailed evaluation (Annex A) to check any computational error/corrections and compliance with the required technical specification and the mathematically calculated bid and ranking arrived are as follows:

WHEREAS, the Technical Working Group (TWG) conducted post-evaluation on the Lowest Calculated Bid, G.R. BERNALES CONSTRUCTION AND SUPPLIES verified its bids responsiveness based on pertinent documents in accordance with the revised IRR of RA 9184 and submitted its findings which are contained in the attached evaluation report (Annex B);

WHEREAS, the BAC upon perusal of the submitted bid, concurred with the said TWG evaluation Report;

WHEREAS, the Committee in its final evaluation found that the bid of G.R. BERNALES CONSTRUCTION AND SUPPLIES in the amount of Sixteen Million Three Hundred Thirty- Six Thousand Three Hundred Forty- Two Pesos and 49/100 (P 16,336,342.49) was evaluated as the lowest calculated responsive and complying bid as compared to the Approved Budget for Contract (ABC) amounting to P 16,341,994.85.

- b) Bank Guarantee confirmed by a commercial bank (in the case of foreign Bidders, bonded by a foreign bank) – Ten Percent (10%);
- c) Surety bond callable on demand issued by the Government Service Insurance System (GSIS) or by surety or insurance companies duly accredited by the Office of the Insurance Commissioner – Thirty Percent (30%); or
- d) A combination of any of the foregoing.


