WHEREAS, the NIA Regional Office No. IV-A advertised the Request for Quotation No. GOODS-CONS-21-006 for the SUPPLY AND DELIVERY OF CONSTRUCTION MATERIALS FOR THE PROPOSED DRAINAGE CANAL OF THE NEW TRAINING CENTER AT NIA REGION IV-A at the PHILGEPS website under Reference No. 7402759 starting JANUARY 9, 2021 and posted same at the bulletin boards of NIA Region IV-A.

WHEREAS, the Approved budget for Contract for the SUPPLY AND DELIVERY OF CONSTRUCTION MATERIALS FOR THE PROPOSED DRAINAGE CANAL OF THE NEW TRAINING CENTER AT NIA REGION IV-A is ONE HUNDED FOUR THOUSAND ONE HUNDRED SEVENTY FIVE PESOS only (₱ 104,175.00).

WHEREAS, as provided in RA 9184 Section 53.9 Small Value Procurement shall be used for procurement not exceeding ONE MILLION PESOS (₱ 1,000,000.00);

WHEREAS, RA 9184 Section 53.9 Annex H also stated that *"The BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This notwithstanding, those who responded through any of the required postings shall be allowed to participate"*;

WHEREAS, all suppliers are required by the BAC to submit Business/Mayor's Permit and Proof of PHILGEPS Registration which is the only documentary requirement in Shopping as an Alternative Method of Procurement in accordance with the ANNEX "H" APPENDIX A of the IRR of RA 9184.

WHEREAS, three (3) bidders/suppliers were invited and submitted proposals, namely: CABERTO BUILDERS, JAS HARDWARE AND CONSTRUCTION SUPPLY and M.A. THOMAS HARDWARE;

WHEREAS, during the opening of proposals on JANUARY 13, 2021 at 2:15 P.M. the following price quotations were received by the BAC and read as follows;






