AVILA CONSTRUCTION** at No. 3, Bucal 3, Maragondon, Cavite called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. KAY AKLE-5M-RRENIS-CY16 - Construction of Canal System of KAY AKLE RIVER IRRIGATION SYSTEM in Maragondon, Cavite** hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **FOUR MILLION THREE HUNDRED TWENTY FOUR THOUSAND TWO HUNDRED NINE PESOS AND 50/100 (Php4,324,209.50)**






