

MEDINA CONSTRUCTION AND TRADING** at No. 322 Matagbak, Talon, Amadeo, Cavite called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. PSONG KSTILA-4M-RRENIS-CY16** - Construction of Diversion Works and Canal System of **PASONG KASTILA RIVER IRRIGATION SYSTEM in Imus City, Cavite** hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **THREE MILLION FOUR HUNDRED NINETY FIVE THOUSAND THREE HUNDRED NINETY THREE PESOS AND 09/100 (Php3,495,393.09)**
